### ENTRY SUBMISSION

We will work diligently to accommodate you in order to get your product submitted in a timely manner.

Intake of samples will be available by appointment, on specific drop off days or by pick up. Drop off appointments can be arranged in the Sacramento area by calling Johny 5 Productions at (916) 787-0101. Custom pickups will be available by appointment for an additional service fee by carrier.

Fair and accurate judging takes time therefore we provide a large intake window to accommodate all of the necessary components involved in scoring each product. In order to allow adequate time for testing and judging we require all entries to be completely submitted by July 26th, 2019. Bring your finest and best!
